The public hearing was opened at 7:05pm by Chair Eve Wittenberg under MGL Chapter 131 §40 Wetland Protection Act and the Code of the Town of Harvard Chapter 119 Wetland Protection Bylaw virtually, pursuant to Chapter 2 of the Acts of 2023, An Act Relative to Extending Certain COVID-19 measures adopted during the State of Emergency, and signed into law on March 29, 2023.

This hearing is for a Notice of Intent for the demolition and reconstruction of a single-family home and attached garage within 200' of Bare Hill Pond at 4 Wilroy Avenue, Harvard.

Dan Wolfe, with Ross Associates, gave the Commission an overview of the project: the current home will be demolished and a new single family residence will be constructed on the same 30'x40' footprint, with the addition of a garage connected to the house by a covered walkway; the driveway and area in front of the garage will be paved; 9 trees will be removed from around the house, several of which are leaning towards the house; the current patio area in front of the house will be replaced by a brick paver surface. No activity will take place in the slope area, which heads to Bare Hill Pond. Mr. Wolfe stated he is aware the hearing cannot be closed tonight and will need to be continued due to the Department of Environmental Protection (DEP) not issuing a number yet. Mark Shaw asked about the waste water system for the home. Mr. Wolfe stated the property owners have a written agreement with their neighbor, the Woods, to share the same septic system. A new pipe will be run from the house to the septic system during construction. Eve Wittenberg had questions regarding an increase in area of impervious surfaces, as well as the lack of a robust replacement plan in place for the 9 trees being removed, and increasing erosion control by the slope. Mr. Wolfe said he has no issue adding an additional line of 100' of silt fence for erosion control and will discuss the aforementioned issues with the property owners. Jessie Panek stated she has an issue with the removal of the oak trees, especially the one near the northeast corner of the house, as its roots most likely have grown towards the pond and are holding the slope in place, and the large oak in the area proposed for the paved parking adjacent to the garage.

This hearing is for a Notice of Intent for the construction of a pervious paver walkway and patio within the 100' wetland buffer zone at 10 Houghton Lane, Harvard.

Dan Wolfe, with Ross Associates, discussed how he had an informal meeting with the Commission several weeks ago and took into consideration modifications specified by Commission members. The area for the patio is currently sloped and would be excavated and leveled, with a layer of clean sand under the bricks, to provide better water infiltration.

Eve Wittenberg stated she would prefer a wood deck instead of pavers as the moss that currently covers the area would provide good infiltration. Mr. Wolfe stated the current area is sloped and if sono tubes and a wood deck were installed, the area would still be sloped and water would not have time to infiltrate the ground. Jaye Waldron asked Mr. Wolfe what the front of the house looked like and would it be a better option for the patio. Mr. Wolfe stated the front yard is sloped and mounded for the septic system. In addition, it would not provide privacy for the family. Mr. Wolfe stated the proposed brick patio gives utility to the back area of the house.

Don Ritchie agrees with Ms. Wittenberg that a wood deck is better than a 2-foot-high brick wall. Jessie Panek and Joanne Ward both agreed with Mr. Wolfe that leveling the area and putting a sand base will provide better infiltration into the ground.

This hearing is for a Notice of Intent for diver assisted suction hose (“DASH”) removal of invasive fanwort and milfoil within the swim area, boat launch and moorings areas within a wetland resource area on Bare Hill Pond.

Bruce Leicher, representing the BHPWMC, stated divers from Pristine Waters LLC, would be on-site for a week in June and a week in August/September to remove invasive species by hand at the root and then have them suctioned-out by hose to a lined dumpster placed in the parking area adjacent to the boat launch area. The lining in the dumpster will be replaced daily and plant material will be taken to a recycling center. Liz Allard stated the application is for both Phase 1 and Phase 2, which include the swim area as well as the adjacent boat launch area and mooring areas and the order is good for three (3) years. Ms. Allard also stated the stormwater management check list, which was submitted with the application, needs to be stamped by an engineer.

The public hearing was opened at 8:05pm by Chair Eve Wittenberg under MGL Chapter 131 §40 Wetland Protection Act and the Code of the Town of Harvard Chapter 119 Wetland Protection Bylaw virtually, pursuant to Chapter 2 of the Acts of 2023, An Act Relative to Extending Certain COVID-19 measures adopted during the State of Emergency, and signed into law on March 29, 2023.

This hearing is for a Notice of Intent for the replacement of a septic line and 3,500 square feet of restoration in the form a rain garden within the 100' wetland buffer zone after enforcement at 351 Ayer Road, Harvard.

Matt Marro discussed how work was done on the property without proper notification, which resulted in the issuance of an Enforcement Order. The property owner plans to install a rain garden to act as a vegetative buffer between two wetland areas on the north and south adjacent properties, and will place plantings in the disturbed area in the 75' buffer zone. Jessie Panek questioned why red oaks were being used as they are not a wetland species. Mr. Marro explained they would act as extra shading for the lawn and wetland areas.

Eve Wittenberg requested that instead of lawn in the 50' buffer, that a wildflower mix or native grasses be used instead.. Mark Shaw stated he has received comments from an abutter that the property owner is not abiding by lot lines and that he is bringing in heavy equipment at all times of day and night. Ms. Wittenberg advised Mr. Marro that the site needs to be monitored, a time line needs to be put in place, and lot lines need to be addressed with the property owner.

Chris Horne, an abutter who resides at 349 Ayer Road, expressed concern that work has been going on for over three (3) years and he would like a timeline for the project. Mr. Horne also stated excavators are being stored on the property, the property has been clear cut and the property owner removed from Mr. Horne's property trees, 60' of fencing (which he has since replaced for Mr. Horne), as well as other plantings. Mr. Marro told Mr. Horne to email him anytime should he have any further issues or questions. In response to Mr. Horne's question regarding the future of the property, Mr. Marro said the property owner intends to replace the septic, rehabilitate the house, and then sell the property.

Ms. Wittenberg advised Mr. Marro to discuss these issues with the property owner and bring responses to the next meeting, including a time line with specific dates for work to be completed.

Matt Marro explained that the septic system failed under Title V and needs to be replaced. A waiver is requested due to the need for minor grading to better offset the ground water at the request of the Board of Health. Extended erosion protection was requested by Liz Allard on their site walk. Several trees and a bush will need to be removed for the leach field. The existing lawn that is disturbed during the work will be replaced upon completion.

Eve Wittenberg questioned whether there will be replacement trees planted. Jim Burns stated that in his opinion, the remaining trees will benefit from the removal, which will now allow adolescent trees to grow and spread in the area. Ms. Wittenberg stated she is satisfied with that and replacement is no longer an issue. Liz Allard will approve the small tweak to the erosion control on site.

Jim Burns made a motion to close the hearing and issue an Order of Conditions with the standard conditions. Mark Shaw seconded the motion. This hearing is for a Notice of Intent for the cleanup and restoration of previous tree clearing, repair of existing pool/patio area, construction of a new patio, farmer's porch and side egress stairs, along with overall drainage improvements zone within the 100' wetland buffer zone at 19 Warren Avenue, Harvard.

Dan Wolfe, from Ross Associates, gave an overview of the project: the owner was having trees and invasives removed by tree company, who removed trees across the property line as well as in the wetlands. The Conservation Agent issued a cease and desist on August 16, 2023] that all work be stopped and all removed trees be identified. In the current application, in addition to clean-up of the downed trees and logs that remain, replanting of trees and shrubs are proposed in multiple areas, the existing pool needs to be relined, the concrete patio around the pool needs to be replaced, an addition of a farmer's porch, a patio to connect new porch and side porch, and repave driveway. The previous owner hand-dug a trench to reroute runoff, so an infiltration trench, filled with stone and piping, will be put in place instead of the hand dug trench. The Notice of Intent includes written authorization from the neighbor authorizing the property owner to replace trees that were removed from their property in error.

Jaye Waldron asked where the septic field is on the property. Mr. Wolfe showed the area on the plan. Ms. Waldron also questioned if there is a plan to keep water from flowing down the driveway to the street, which creates an ice hazard in the winter months. Mr. Wolfe stated the homeowner is working with the Department of Public Works to address this in the repaving permit process. Mr. Wolfe also stated there is an existing swale that handles the runoff.

Don Ritchie questioned the need for the patio area between the farmer's porch and the side porch, when they have a large patio in the pool area. The property owner stated he would be okay with a path connecting the porches in lieu of the patio area. Jessie Panek asked if they would consider adding wet tolerant trees to wetland area to aid in keeping out invasives. Liz Allard said there is a large amount of debris in the area, once that is cleared she will do a site visit with Mr. Wolfe to discuss the additional plantings.

The public hearing was opened at 9:04pm by Chair Eve Wittenberg under MGL Chapter 131 §40 Wetland Protection Act and the Code of the Town of Harvard Chapter 119 Wetland Protection Bylaw virtually, pursuant to Chapter 2 of the Acts of 2023, An Act Relative to Extending Certain COVID-19 measures adopted during the State of Emergency, and signed into law on March 29, 2023.

Others Present: Liz Allard (Conservation Agent), Bob O'Shea (Harbor Master), Anne McWaters (Recreation Director) and Nick Pauling (GPR Inc.).

This hearing was continued from March 21, 2024 for a Notice of Intent for public safety improvements, stormwater management and handicapped access within the 200' wetland buffer zone to Bare Hill Pond at 31 Pond Road, Harvard.

Bob O'Shea stated Parks & Recreation hired a consultant, GPR Inc., to prepare a plan showing the specifications for the two new ADA compliant parking spots. Nick Pauling, of GPR Inc., presented the plan to the Commission.

Liz Allard stated the new plan is a great improvement to the area, including the new berm along the west side of the parking area, which will assist in draining storm water from the parking area toward an existing rain garden. Ms. Allard will send the plan to the Bare Hill Pond Watershed Management Committee for their comments, which she will present at the next meeting. Mr. Pauling mentioned to Ms. Allard that he is aware that he still needs to submit the formal request for a waiver.

With no comments from DEP or a file number, along with items to be addressed Jim Burns made a motion to continue the hearing to April 4, 2024 at 8:20pm. Jaye Waldron seconded the motion. The vote was unanimously in favor of the motion by a roll call: Don Ritchie, aye; Jaye Waldron, aye; Joanne Ward, aye; Jim Burns, aye; Mark Shaw, aye; and Jessie Panek, aye.
